#### On The Air

Radio isn't just for breakfast anymore. But the poor turnouts I've seen at Public Service events that happened to be held on "Breakfast Saturdays" recently are starting to make me wonder.

Presenting ourselves as responsible, skilled communicators who freely offer our communication services to our neighbors and communities will serve us well when it comes time for consideration of antenna ordinances and zoning issues. If you set a good example, you may be pleasantly surprised when people ask you about becoming hams.

Case in point: An informal group of hams—some club members and some not—from our area and Pittsburgh worked together to provide vital communications support for the "Baker Trail Ultra Challenge," a 50-mile footrace. Lest you think Amateur Radio was just a "tag-along" allow me to disabuse you of that notion—Amateur Radio played a key part, and the hams who helped were overworked at times. The was so much traffic on the 147.105 repeater that it was most likely the busiest day it ever had. That is how much we are needed!

But wait! There's more. Over the past several years that our local hams have provided this service, the event organizers have been impressed—so much so that *they* have studied for exams and obtained their own Amateur licenses! That's right—by simply participating in a one-day event, we inspired people to become hams!

Jefferson County ARES Emergency Coordinator Kevin Snyder KA3YCB was pleased with the participation, but was concerned that the group was short by at least one ham. (You know who you are.)

We hams are a helpful lot. We like to think we take public service seriously. We brag about our ability to provide communications "When all else fails." (I wonder--do we have to wait until everything else fails, or can we start providing communications **before** things get that bad?)

We point with pride to Amateur Radio's past achievements like the Hurricane Katrina response. But I wonder how many of us who are telling the story actually participated in those events in a meaningful way.

In my travels to various club meetings, one of the main topics I hear is Emcomm this and Emcomm that, and that reflects very well indeed on our good intentions. We're on the right track when we recognize our obligation to serve our communities and neighbors.

What amazes me however is that when we are presented with an actual opportunity to serve the public, not enough of us show up to help. We need to show up in force!

But look out when the dinner bell rings! Don't stand in the way, lest you get trampled by a hungry herd of hams! (Yes, I know that food is the most powerful motivational force on the planet, but *really!*)


When I first started in Amateur Radio some 45 years ago, hams had to be active. In fact, you had to be able to prove by your logbook (remember those?) that you had been active on the air, or you were not permitted to renew your license! Maybe that's one reason why today, although we have more hams than ever (on paper) we see fewer and fewer at our meetings and activities.

Deep down, all people feel the need to be of use to each other, and that instinct has served mankind since the dawn of history. How many times did you feel slighted when

there was an emergency but you and your ARES buddies weren't "activated?"

It kind of rubs you the wrong way when you've been checking into ARES nets and talking about emergency communication at club

breakfasts for years, but when the tornado or flood or blizzard hits, the EMA doesn't ask for all that help that you're just aching to provide. It almost feels like they don't even know you exist.



You see, the EMA Director and the other served agency officials most likely never heard you checking into the ARES net, because they aren't hams (let alone ARES members!) They never heard your wonderful Emcomm discussions at the club breakfasts because they weren't at the club breakfasts!

Where were they? I'll tell you where they were. They were at that footrace or car show or bicycle tour or parade or fair or whatever other Public Service opportunity you blew off because someone had the audacity to schedule it on Breakfast Saturday. That's where **they** were! And their opinion of our usefulness is shaped by our activity level.

Now don't get me wrong—if you have to work, or your family needs you, by all means take care of business on the home front! As the *Amateur's Code* says, "The Amateur is Balanced." What I'm talking about is assigning the proper priorities to club socials versus operating in the Public Interest. I think we all know which is more important!

Meeting called to order by President Dave AA3EJ at 15:08 UTC.

VE Testing — General discussion about no scheduled VE sessions. Joe KB3CBN is the PARA Contact VE for the ARRL testing program. Joe was not in attendance nor has be attended other club functions this summer. John N3SPW volunteered to contact Joe and determine Joe's interest in the PARA VE Testing Team. Follow up report due at the October meeting.

Membership Report – Two new members since the last PARA business meeting: Ted Trostle WB2LOU of State College and Carmine Prestia K3CWP. Membership currently stands at 29 with 24 voting, 5 non-voting. 72% of PARA members are ARRL members.

**Repeater Reports** – discussion lead by Filip AB3HK.

**146.640-(PL173.8Hz) repeater** – A new Diamond 6 db gain antenna was installed. Reports are that coverage was significantly improved with the added gain.

**144.390 PARS Digi-Peater** – operating normally with no reported issues.

146.430 (+1 MHz, PL 173.8 Hz) repeater —
The new repeater is not yet on-line. The
manufacturer says that double shielded
cables are a must for interconnection
between the duplexer and repeater unit. Ted
offered to donate some double shielded cable
for this purpose. Filip will coordinate with Ted
and Lou to get the proper connectors
installed on the cable. Filip received an offer
from Ephrata Area Repeater Society to
purchase a used Telewave ANT150F6-2
antenna. After discussion it was decided to
pass on this offer. Further discussion on
antennas continued. Ted mentioned that he
has in his garage a Cushcraft 4-bay dipole

antenna that might be suitable for repeater use. Ted is going to look at the antenna and find the model number so we can determine its specifications. It was decided that the style of antenna we should use is a 4-bay folded dipole style antenna that will allow us to customize the directional pattern as necessary.

#### "The Big .43" Repeater Updates by John Szwarc N3SPW

September 24—Filip AB3HK, Dave AA3EJ and Lou WB3AAI made a visit to "The Big .43 Repeater" tower site. They switched out the old GE Master II repeater with the new HiPro R1 repeater. And this time we had double shielded interconnect cables courtesy of a donation by Ted WB2LOU and some preperation work by Filip AB3HK and Lou WB3AAI.

The first big test of the new equipment was the Saturday 9 PM net. Everything seemed to work flawlessly. The receive sensitivity seems to be much improved and many stations commented about the improvements. There is still some technical tweaking that needs done, but at this point it appears the project was a huge success.

The next step is to bring EchoLink back on line. Hopefully that will happen in the next week or so. The final step will be to replace the antenna with a higher gain model. I'd expect the antenna project to be a topic of discussion at the October PARA meeting on October 8th.

If you weren't on the net, please give the new repeater equipment a try. We're very interested in hearing signal reports from everyone.

October 1—Filip AB3HK reports, "After extensive testing with a dummy load and various components of the system, the following was determined:

- 1. The repeater, amplifier, and duplexers are working well into a dummy load. 60+ watts OUT, at 1.5:1 VSWR
- 2. The antenna system is operating with a high VSWR value >5:1.

"Problem: The coax line between the duplexer and antenna may be bad. We need another coax with N on both ends, app. 10 -12 feet in length, AND/OR there is a problem with the hardline AND/OR the antenna.

"Recommendation: A new section of coax between the duplexers and hardline should be installed. The antenna system should be analyzed PRIOR to placing the repeater and amplifier back into service."

The 146.430 has been shut down due to a high VSWR condition in the antenna system. All 146.430 activities should be moved to 146.760 until further notice.

October 2—The Big .43 Repeater is back on the air, although issues persist with the antenna. Dave AA3EJ was at the site earlier today and installed a new cable between the hardline feed point and the duplexers. Thanks Lou WB3AAI for you quick handiwork on preparing the needed cable.

Dave AA3EJ reports, "Installed WB3AAI cable from duplexer to overhead input RF antenna connection. Turned on system, PS current draw almost 20a. Suspect medium SWR keeping pwr down.

"Recommend swapping out old low gain (faulty ??) antenna with higher antenna and analyzing the antenna system down to the building with an RF analyzer/refllectometer by the RF tech who is going to install the new antenna..REMEMBER..The repeater system is about 1.3 to one into a dummy load placed into the "tee" at the duplexer (antenna feed!)..the SYSTEM works into a proper match..the "Henry" doesn't like high swr and will blow the fuse if hi swr exists to protect itself...

"I left with the system operating and almost drawing 18a or so..."
